May be mailed to Election Committee, c/o Detroit Federation of Teachers, 7700 Second Avenue, Suite 427, Detroit, MI 48202. Must be in DFT office by 5:00 p.m. Wednesday, October 12, 2016 or hand delivered to the Election Committee at the October 13, 2016 Membership Meeting.
October 13, 2016 (Thursday)	<u>MEMBERSHIP MEETING.</u> List of nominees posted and additional nominations will be accepted from the floor. <u>NOMINATIONS CLOSED</u> as last order of business.
October 17, 2016 (Monday)	Notice sent to those nominated with request for acceptance and statement for Special Election Edition of the DETROIT TEACHER.
October 24, 2016 (Monday)	Second notice to those nominees who have not responded.
October 31, 2016 (Monday)	<u>DEADLINE FOR ACCEPTANCES AND STATEMENTS.</u> Must be mailed or hand delivered to DFT office by 5:00 p.m.
November 1, 2016 (Tuesday)	List of eligible candidates sent to each candidate and to schools for posting. Notice sent to candidates who did not send a statement for the DETROIT TEACHER that no information will be printed.
November 3, 2016 (Thursday)	<u>DEADLINE FOR FILING GRIEVANCES</u> on nominations and acceptances. Grievance(s) heard by Election Committee and Executive Board.
November 10, 2016 (Thursday)	Grievance Appeal(s) to membership Thursday, November 10, 2016
November 14, 2016 (Monday)	Ballots mailed to member's homes. <u>VOTING BEGINS.</u>
November 25, 2016 (Friday)	<u>Voting Ends.</u> Ballots mailed back to American Arbitration Association.
