## 5. Election Committee Report

#### 6. PAC Report

Marcus Walton gave the report this evening. There are 5 points from last month to this month. Tyre Nichols, Dr. King, Ron DeSantis, DFT Political Action Committee, Democratic National Committee are all connected to political action. When we don't hold people accountable, we will continue to have people mistreat us. We have to be the line to say, "not anymore." Without knowledge, society loses itself. Please know that the work done in this capacity is very sensitive, so we take this position very seriously. We will continue to monitor to find a replacement for this position.
- Yolanda King reports that there are 9 new/recommit members to the DFT. I am reaching out to people and trying to keep people on track. # 8. President's Report

- a. Right to Work We are wall to wall in Democrats! How long will we have this favor towards educators? Everything is moving at lightning speed. I have been in contact with some to participate in a campaign/video as to the repeal of Right to Work. Some members will be featured in a publication with Meghan Douglas to speak with Detroit teachers on their feelings about the need to repeal Right to Work.
- b. Contract Campaign We are at the ready of a new contract. Our current contract expires on June 30, 2023. As we move into this campaign, we will be meeting with different members, Executive Board Members, committee members and Building Reps to get information. We will also be putting out surveys to help gain an understanding of all the nuances that need to be addressed in the coming contract.
- c. Grievances: Blended Learning, Headstart, EDIC, Project Find The District has provided information of members who have been paid for Headstart/EDIC/Project Find. There were other members who do not work in some of these places who were paid and did not work. The Blended Learning Stipend is a bit more nuanced. Our attorneys are still going back and forth with this issue. It is because we do not agree that we are still working.
- d. Organizers I am hoping that people take advantage of the Union Building Institute and take an interest in learning about Union building. We want the next shoes in this position to be the right fit. No applicant mentioned discounts, or even the liability insurance that Union membership offers. This is where we are with our Members and how much they actually know about the Union.
- e. Southeastern H.S. Staff and students have been online since January 9<sup>th</sup>. The school may not be back to in-person learning in May. They are currently preparing Frederick Douglass to accept Southeastern, as the district does not want to lose any more students. AFT will show their appreciation to the staff of Southeastern HS with a special presentation this Saturday at the DIA event of the Rebellious Life of Rosa Parks. Be there early, as the reception begins at 6:00 p.m.
- f. We are S.T.R.O.N.G.E.R. Together! We need to realize that we are stronger together regardless of our differences in opinion and strategies in getting

things accomplished. We need to be strategic in how we proceed. In the end, we agree on education and on kids.

# 9. Executive Vice President's Report

- a. Public Service Loan Forgiveness Survey AFT President Weingarten sued the Department of Education during the Trump Administration about loan forgiveness. The ask is for more transparency, better communication and an easier and clearer process for loan forgiveness. She has the ear of President Biden and wants to give him more data about loan forgiveness, so we are going to be asking members to complete a survey on loan forgiveness.
- **b. DFT Committees** Committees are ways of engaging with our members and building capacity. Some are very active and our goal is to have Executive Board Members on each committee to help build capacity.
- **c. Regions** Five years ago, this was brought to the forefront. We have had some starts and stops with this, but we need this in place to keep reps informed and to get information back.
